#### 6.3.4 Research and Development

College has Research Recommendation Cell which promotes the research activities in the college. The chemistry and physics department have planned to submit their minor and major research projects during academic year 2013-14 to the UGC, New Delhi. The department of Physics has also decided to resubmit its proposal for research centre affiliation from Shivaji University, Kolhapur.

#### 6.3.5 Library, ICT and physical infrastructure / instrumentation

The college has separate building for library which contains more than 45,000 books including reference books and text books. The Computer laboratory has more than 60 computers for better use of ICT in the academic as well as administration. The building has 19 classrooms eight laboratories, athletic track of 8 lanes, kho-kho ground, Kabaddi ground, others.
