GENERAL AGREEMENT FOR ACADEMIC CO-OPERATION (MoU)

3) Confidential Information:

Each party should bind to keep information as confidential, at all times during the term of this agreement and for a period of five years. This confident disaformation will not be disclosed to any person, other than employees who need to know the purpose of performing their functions, without the consent of owner of the confidential information.

4) Co-operative research and intellectual property:

Either party to this agreement may propose to the other specific individual research projects for collaboration, such proposals may be made at any time or individual project agreement will be drafted for each research project.

Protection and exploitation of any valuable intellectual property arising out of a research project will be addressed to each individual project agreement.

5) Termination of agreement:

Upon termination of this agreement for any reason, the parties shall return all confidential information to the owner institution. The notice of termination of this agreement need to be given six months in advance.
