

GENERAL AGREEMENT FOR **ACADEMIC COOPERATION** off tweethe (MoU) of the



BETWEEN RAJE RAMRAO MAHAVIDYALAYA JATH, DIST-SANGLI-416404 with our ci security AND AYSINGPUR COLLEGE, JAYSINGPUR, DIST- KOLHAPUR-416101 This is a General Agreement for establishment of collaborative academic effort between RAJE RAMRAO MAHAVIDYALAYA JATH, DIST-SANGLI-416404 and JAYSINGPUR COLLEGE, JAYSINGPUR, DIST-KOLHAPUR-416101.

1. It is hereby agreed that these two institutions shall cooperate on the following activities:

a) Exchange of Faculty, students and scholars at both Institutions.

- b) Sharing of equipment's, garden & library facilities for education & research.
- c) To organize joint training programs, seminars, workshops & conferences.
- d) Joint publications & filing of patents based on collaborative research work.
- e) Submission of joint research projects to various funding agencies.
- f) Providing testing services at reasonable rates.

2. Implementation

- a) In order to carry out the above-mentioned activities, detailed plans of the academic cooperation, strategies for the interactions, and mechanisms leading to the exchange of faculty and students shall be formed through consultation between the two institutions and expressed in academic agreements.
- b) Both institutions shall agree to seek financial support for the mutually agreed cooperative activities defined in the above from appropriate agencies of their respective government and other agencies.
- c) This Agreement will be effective for five (5) years after the date of signing. This Agreement is renewed automatically as long as neither party gives notice of termination to the other.

3. Confidential Information

Each partyshall, at all times during the term of this Agreement and for a period of five (5) years after, keep confidential any confidential information received from the other party. Such confidential information will not be disclosed to any person, other than employees who need to know for the purpose of performing their functions, without the consent of the owner of the confidential information.

4. Cooperative Research and Intellectual Property

Either party to this Agreement may propose to the other specific individual research projects for collaboration. Such proposals may be made at any time and an individual project agreement will be drafted for each research project. The

protection and exploitation of any valuable intellectual property arising out of a research project will be addressed in each individual project agreement.

5. Termination of Agreement

Upon termination of this Agreement for any reason, the parties shall return all confidential information to the owner institution. The notice of termination of this Agreement needs to be given six (6) months in advance.
