

**Memorandum of Understanding  
Between**

**SHRI SWAMI VIVEKANAND SHIKSHAN SANSTHA KOLHAPUR'S  
RAJE RAMRAO MAHAVIDYALAY JATH, DISTRICT- SANGLI**

**And**

**HITTI AYURVEDIC AGENCY, JATH-416404, DIST-SANGLI**

Both the above-mentioned parties wishing to develop friendly and cooperative relations in the fields of education and research have agreed to establish the present Memorandum of Understanding (MOU).

**I. Subject of the Agreement**

Both parties agree to explore the following general forms of cooperation:

- 1) To create awareness among the students, parents and people regarding various ayurvedic medicines, provide guidance to the farmers and students on identification, cultivation and conservation of medicinal plants, human disease and ayurvedic formulations.
- 2) To develop interaction between farmers, students, scientists from botany department and experts from the ayurvedic medicine experts.
- 3) To encourage faculty / students / of RRC, Jath and Government Nursery to participate in program of common interest.
- 4) To create awareness among the faculty/students of RRC, Jath in identification of medicinal plants and preparation ayurvedic formulations and medicines.
- 5) Training of RRC, Jath staff/students and farmers from Jath through Continuing Education Programmes in areas of interest to RRC, Jath and Hitti Ayyurvedic Agency, Jath
- 6) Any other appropriate mode of interaction agreed upon between RRC, Jath and Hitti Ayyurvedic Agency, Jath.

**II. Proposed mode of collaboration**

1. Cooperation and promotion of education, research and training in areas of mutual interest.
2. Any other appropriate mode of interaction agreed upon between RRC, Jath and Hitti Ayyurvedic Agency, Jath
3. A specific plan will be worked out by the parties depending upon availability of resources. A specific agreement will be entered into for such activity if necessary.

**III. Terms and conditions**

1. This MoU may be amended, renewed and terminated by mutual written agreement of the parties at any time.
2. Either party will have to right to terminate this MoU upon 60 days prior written notice to the other party.

**IV. Confidentiality**

1. The RRC Jath and Hitti Ayyurvedic Agency, Jath agree to hold in confidence all information / data designated by parties as being confidential which is obtained from either party or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other party.
2. The above confidential clause under this MoU exclude the information / data possessed by either party before entering into this MoU or independently developed and / or already available through public domain.

**V. Duration of MoU**

This MoU, unless extended by mutual written consent of the parties, shall expire in two years after the date specified in the opening paragraph. However, on review, the MoU shall be extended for another two years by mutual consent.

**VI. Coordinators**

Both parties will designate persons who will have responsibility for coordination and implementation of this agreement.

## VII. Signed in duplicate

This MoU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the parties, acting by duly authorized officers have caused this Memorandum of Understanding to be executed, effective as of the day and date first above written.
