# Deliverables from Environment and Sanitation department, Jath Nagar Parishad, Jath.

- 2. Providing platform to our students to undergo short projects and internship programs under the Environment and Sanitation department, Jath Nagar Parishad, Jath.
- 3. Organizing events for the promotion of Cleanliness awareness friendly products.

- 5. Help college to promote Sustainable Development Practices.
